

# **INTRODUCTION:**



### **ROLE DESCRIPTION AND PURPOSE:**

Do you have a passion for education and using sport and physical activity to inspire children to realise and reach their full potential?

Oxford United in the Community are seeking a Primary Schools Lead to lead and manage our Premier League Primary Stars Programme, and other delivery in schools within Oxfordshire including assemblies, educational workshops, player visits and Extra-Curricular Activity.

The main focus of the role is to deliver the Premier League Primary Stars programme, including responsibility for delivering KPIs set by the Charity and Premier League Charitable Fund, and to liaise with schools, organise workshop delivery and events and deliver a successful programme in line with Premier League Charitable Fund expectations and grant terms and conditions.

The Primary Schools Lead will utilise Premier League Primary Stars resources to deliver a weekly programme of activities within partner schools to enhance teachers' knowledge, skills and confidence in the planning and teaching of Physical Education. The project aims to increase children's enjoyment of physical activity, develop their personal skills and increase their confidence in English and Maths by using sport as a means to engage.

The role will report to the Chief Operating Officer, and work closely alongside our other programme leads and key pillars to deliver increased impact for the Charity within Oxfordshire.



## **MAIN DUTIES AND RESPONSIBILITIES:**

- Lead the planning and delivery of a range of educational events and activations within school settings including:
  - Supporting PE lessons support primary school teachers by developing their skills, knowledge and confidence to plan and deliver PE lessons in line with the national curriculum.
  - o Targeted Interventions engage with pupils who have been identified as having a targeted need and require additional learning or support in either PSHE, English, match or football-focussed learning.
  - o Girls-only extra-curricular football to inspire and engage a new generation.
  - Projects for positive change to engage children in positively impacting their local community.
  - o Themed Workshops focussed on PSHE, English, Maths and/or parent engagement.
  - o Competitions such as schools tournaments and/or sports days that inspire and engage pupils through sport and physical activity.
- Managing monitoring, evaluation and impact measurement of the Premier League Primary Stars programme, including developing effective case studies, collection of data, surveys and delivery of Premier League Charitable Fund KPI's.
- Be the main point of contact for all funder requirements for the Premier League Primary Stars programme, including bi-annual report writing and impact reporting.
- Proactively manage relationships with all partner schools, delivery of services, adhering to agreed Service Level Agreements and ensuring appropriate planning and delivery in line with Charity, funder and school expectations.
- Representing the Charity in relevant local and regional steering groups and with relevant local authorities for example local council, education establishments and other relevant partner organisations including Oxford United Football Club.
- Liaise with parents/carers, schools, teachers and other outside agencies as necessary to deliver our work in primary schools.
- Create half-termly syllabus and manage a team of coaches to deliver our extra-curricular activities ensuring a range of experiences and focus for pupils across the year.
- Attend relevant funder training and development opportunities, including conferences and events.
- Working as an individual and as part of a team, adaptable to working with different primary schools.
- Excellent communication, written and verbal and in a range of settings.
- Work closely with the Designated Safeguarding Lead to ensure all programmes and sessions are run in accordance with the safeguarding requirements of the Charity and Club.
- Always promote a positive and professional image of the Club and Charity within schools.
