The focus of the role is to deliver sessions in our programmes in a safe and inclusive environment, using the power and fun of football to help children have fun and develop new skills.

Sessions are mixed gender and mixed ability, with ages ranging from 5-11

The role will report into programme lead – which is the Holiday Camp Lead

- To consistently plan and deliver professional high quality coaching sessions that help to create positive experiences for participants in a holiday camp environment.
- To liaise with the Holiday Camp Programme Lead to ensure that all sessions are delivered in a safe and enjoyable environment.
- To be punctual and organised, ensuring that all equipment is prepared, and the venue is ready prior to the arrival of the participants.
- Create a fun, inclusive, and safe environment for all participants
- Take registers and ensure children are signed in/out of sessions
- To adhere to safeguarding policies and procedures as outlined by Oxford United in the Community and report any safeguarding or welfare incidents to the appropriate Programme Lead
- Follow instructions and work in accordance with risk assessments
- Communicate any issues or feedback to programme leads
